# **Our Philosophy**

At the heart of the Save Lives Oregon philosophy is the belief that many roads lead to recovery. Our approach is informed by the extensive research\* that demonstrates the effectiveness of harm reduction strategies in reducing overdose fatalities, infectious disease risks, and injuries related to substance use, while also enhancing access to health and social services.

### Communications Resources & Materials

Create and distribute tools and materials to help our partners explain and share about harm reduction strategies in their communities.

## The Harm Reduction Clearinghouse

Distribute state-funded harm reduction supplies equitably and free of charge to organizations that meet eligibility criteria.

Facilitate educational trainings and provide support to organizations seeking to integrate harm reduction strategies into their services.

# Community-led, community-driven

With a large network of diverse statewide partners including community organizations, Tribal groups, local agencies, health centers and more, we've honed our initiative offerings based on partner feedback. In 2023, we hosted community listening sessions with Black, Native, and Latinx service providers and peers to better understand culturally-specific needs and barriers related to substance use harm reduction. Through insights from these sessions, and survey data we collect from all initiative partners, we've expanded initiative offerings to include new monthly Learning Collaboratives and an expansion of supplies available through the Harm Reduction Clearinghouse. Our goal is to ensure Save Lives Oregon remains community-centered and effectively responsive to our partners' needs.

## **Expanded reach & impact**

In 2023, the Save Lives Oregon initiative expanded its Harm Reduction Clearinghouse to offer a broader range of partners statefunded harm reduction supplies. While we continue to prioritize the distribution of naloxone and other supplies to partners in high yield settings - those where supplies are directly distributed to people who are using substances and those most vulnerable to overdoses we now provide access to state-funded naloxone and other supplies to additional partners such as special districts, schools, colleges and school-based health centers. This expansion was supported by funding from the Opioid Settlement Prevention, Treatment and Recovery Board.



#### **Maximizing Fiscal Efficiency**

The Harm Reduction Clearinghouse bulk purchases supplies - including naloxone, the medication that reverses opioid overdose - through our State's Division of Administrative Services (DAS) bulk purchase agreement with a national group purchasing organization for governments, operated by the State of Minnesota, which negotiates the lowest prices for supplies for over 13,000 members across all 50 states.
